This Agreement is made this _____ day of _____, 2008 by and between International Nanny Association (hereinafter "INA") and _____ (hereinafter "Exhibitor"). For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Exhibitor agrees that its access to and use of the premises, equipment and facilities located in the Radisson Resort Orlando - Celebration, INA Conference, 2900 Parkway Blvd., Kissimmee, Florida 34747, on May 1 through May 4, 2008 and for the purposes hereinafter specified, will be governed by the following terms and conditions:

- Exhibitor agrees that INA, its directors, members, employees and agents are now and hereafter relieved of any and all responsibility and liability for all injuries, loss or damages that Exhibitor or its employees, agents, and invitees, or their property may incur as a result of or during Exhibitor's use of the said premises, property, equipment and facilities provided by INA. Exhibitor on its own behalf and on behalf of its employees, agents, and invitees, hereby agrees to hold harmless, indemnify and defend INA, its directors, members, employees and agents from and against any and all costs, damages, fees, expenses or liability of any type or nature related to same.
- Exhibitor acknowledges that INA, its directors, members, employees and agents, do not maintain insurance covering property brought onto the said premises by exhibitors and that it is the sole responsibility of Exhibitor to obtain insurance covering such losses.
- Exhibitor further covenants and agrees to indemnify and fully pay and reimburse the hotel owner any and all costs of replacement and damaged hotel property, and for the restoration and repair of the premises, property, equipment and facilities of the hotel or INA which are in any way damaged, destroyed, or otherwise defaced or injured by Exhibitor's, its employees', agents' or invitees' use of same.
